




Symposium Goal

To improve the quality of patient care by providing healthcare professionals with an in-depth update on new techniques and research in the treatment of traumatic brain injury and stroke patients.

Educational Objectives

Upon completion of this conference, participants should be better able to:

- Recognize clinical presentation based on neuropathological findings of chronic traumatic encephalopathy (CTE).
- Evaluate unanswered research questions regarding CTE, and review the recent research designed to answer these questions.
- Review the physiopathology of seizures and identify the different seizure types in the brain injury patient.
- Recognize complications associated with seizures in brain injury patients.
- Diagnose and implement treatment for seizure disorders in the high-risk population of brain injury patients.
- Explain the critical role of the non-physician caregiver in the identification of seizures and treatment complications in the brain injury patient.
- Identify three types of frontal lobe dysfunction that can occur following traumatic brain injury.
- Differentiate between psychological and neurological causes of affective dysfunction following frontal lobe injury.
- Describe different treatment approaches to frontal lobe dysfunction.
- Distinguish between competence and decision-making capacity.
- Review recent data on results of deep brain stimulation (DBS) in patients with Parkinson's, essential tremors and dystonia.
- Identify the indications for DBS and select patients appropriately.
- Explain DBS therapy and its mechanism of action.
- Explain the pathophysiology, imaging and morbidity of hemorrhagic and ischemic stroke.
- Assess recent advances in the treatment of acute hemorrhagic and ischemic stroke as compared to traditional options.
- Describe the theory and current evidence-based data behind body weight support (BWS) gait training programs, including neuroplasticity, task-specificity and massed practice.
- Identify appropriate candidates for BWS gait training and design a BWS gait training program based on current evidence.
- Modify treatment parameters, as indicated, to maximize patient outcomes.
- Examine advances in neurologic rehabilitation devices and equipment including robotics and wearable active devices.
- Identify the indications for their use and select patients appropriately.
- Evaluate the future implications of brain-computer interface devices for neurologic rehabilitation.

- Explain the uses of Kinesio Taping® for face and oral cavity rehabilitation in the pediatric dysphagia patient.
- Combine alternative and traditional treatment strategies to support the nutritional goals of the pediatric dysphagia patient.
- Describe how concussion and mild traumatic brain injury differ from post-concussion syndrome (PCS).
- Identify problems with the construct of PCS.
- Identify commonly occurring conditions that overlap with concussion and PCS and have similar clinical presentations.
- Utilize an approach to confirm or rule out the diagnosis of a past/remote unobserved concussion.
